NOTICE OF ESTABLISHMENT AND CERTIFICATE OF AUTHORITY

NOTICE

1. **Divine Foundation.** The Nation of Free American Family Order (F.A.F.O.) is created from the guidance of GOD, under GOD, and by GOD. Therefore, all internal laws, governance, and rules of the Order shall first align with GOD's Laws as derived from the Word of GOD, the Holy Bible.
2. **Establishment.** Notice is hereby given that Free American Family Order (F.A.F.O.) is established and exists as a private, voluntary, unincorporated association formed by private agreement for family legacy governance, private education, stewardship, and internal administration.
3. **Authority.** The undersigned is the King / Founding Authority of F.A.F.O., authorized to issue directives, certify governing instruments, appoint, change, remove, or replace Ambassadors and representatives, and execute instruments necessary to administer the Order's private affairs, to ensure the protection, safety, and transparency of the Nation/Order.
4. **Domicile for Governance / Seat of Internal Governance.** For internal governance, recordkeeping, administration, issuance of credentials, and meetings, the Order designates its Domicile for Governance / Seat of Internal Governance at:
Latitude: 33.373647, Longitude: -112.154014 thru, 33.373969, Longitude: -112.154015 thru, 33.373777, Longitude: -112.154063 thru, Latitude: 33.373786, Longitude: -112.153923 situated near southwest of Phoenix, located west of 43rd Avenue and north of Dobbins Road, within the Republic of Arizona.
This domicile designation is for internal administrative purposes only and may be changed by express written authorization of the King, memorialized in the Order's private records.
5. **Mailing Address for Notice.** Official notices, correspondence, presentments, and communications for the Order may be directed to:
PO Box 680, Laveen, Arizona 85339-0680.
6. **Records Custodian.** The King, or a Secretary/Recorder appointed in writing by the King, is the custodian of the Order's Minutes, Resolutions, credentials, and certifications, and may certify copies of records as true and correct for verification purposes.
7. **Accounts and Administrative Interface Authority.** The King, and any Ambassador, Officer, or representative specifically appointed in writing by the King and acting within the scope of that written authorization, may open, maintain, modify, and close accounts (including deposit, custody, investment, and other financial or administrative accounts) with any corporation, financial institution, custodian, broker, or other entity, for Order purposes.
8. **Seal / Crest** F.A.F.O. maintains a private seal/crest used for authentication of internal instruments and credentials. Unauthorized use is prohibited. (Exhibit A attached.)
9. **Rule of Construction — Common Law Foundation.** The Order recognizes the Common Law of England as the foundational basis of law and rights preserved in the Arizona Constitution and the Constitution for the United States of America. Accordingly, for internal governance and interpretation of its private agreements, the Order construes its rules to preserve fundamental rights and rejects, as a matter of internal policy and non-consent, any statute, code, regulation, or policy that is repugnant to those constitutional limitations or that purports to remove or diminish inherent rights of the people. 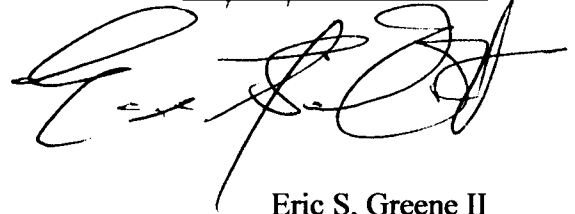
clause states the Order's internal governance standard and does not authorize unlawful acts.

10. **Non-Territorial Disclaimer.** This Notice is filed as a public notice of existence and administrative points of contact only. Nothing herein shall be construed as a public territorial claim, an assertion of exclusive jurisdiction over land not lawfully controlled by the Order, or any interference with lawful property rights of others.
11. **Effective Date (Nunc Pro Tunc).** For internal continuity and record correction, the Order recognizes its governance as effective nunc pro tunc to January 1, 2025, to the fullest extent consistent with private contract and lawful enforceability.

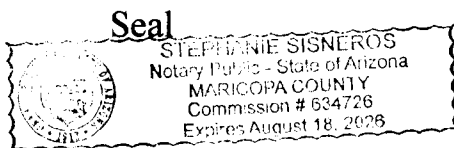
